# LPNS Progress - and an unexpected encounter

The November 2014 newsletter set out what we have so far achieved and discussed the need for a strategy to overcome the difficulties presented by a lack of Tithe Commutation Schedules for certain parts of pre-1974 Lancashire.

In the last newsletter we discussed the work undertaken on the Land Tax Returns. This work helps us to identify the major landowners and continues to reveal the unexpected.

When Farrar and Brownbill wrote about Salford Hundred in the *Victoria County History*, they discussed how an area called 'Hundersfield' was recorded between 1202 and 1361 and noted that it included quite large areas in east Lancashire. They named Wardleworth, Wuerdle, Wardle, Blatchinworth, Calderbrook, Todmorden and Walsden which together cover over 16,000 acres.

Trawling the Land Tax Returns has revealed that the area was recognised long after the dates given in the Victoria County History. All the Land Tax Returns for the places listed above locate the 'hamlets' as being within Hundersfield Township.

It seems likely that parallels can be drawn between Hundersfield and 'Makerfield' which gives an identity to Ashton in Makerfield and Newton in Makerfield both of which lie in the south-west of the county.

This discovery (to a degree) confirms the writer's belief that, with a range of taxes and levies being made each year, every township developed its own method of managing the collection. Consequently, ancient concepts were, to a degree, frozen by 'custom'.
